WHEREAS, under clause (c) of sub-section (1) of section 7 of the Kerala Cooperative Societies Act, 1969 (21 of 1969), the area of operation of the proposed society and area of operation of another society of similar type shall not overlap;



AND WHEREAS, the said provision acts as a bar on the operation of more than one Co-operative Society of similar type in the same area;

AND WHEREAS, the Kuthuparamba Co-operative Urban Bank Limited No.985 in Kannur District has been functioning as a primary Co-operative Urban Bank, having area of operation in the Municipality of Kuthuparamba, Panchayath of Mangattidam, Kottayam and Pattiam of Tellicherry Taluk in Kannur District;

AND WHEREAS, the Reserve Bank of India has rejected the request of Kuthuparamba Co-operative Urban Bank Limited No.985, under the Banking Regulation Act, 1949 (Central Act No. 10 of 1949) to continue as an Urban Co-operative Bank;

AND WHEREAS, Six Primary Agricultural Credit Co-operative Societies are functioning in the area of operation of the said Bank;

AND WHEREAS, the Board of Directors of the Kuthuparamba Co-operative Urban Bank Limited No.985 has resolved to request the Government through the Registrar of Co-operative Societies to exempt the said Bank from the restriction regarding area of operation provided in clause (c) of sub-section (1) of section 7 of the said Act so as to enable the Registrar of Co-operative Societies to alter the classification of the said Bank as a Regional Co-operative Bank under rule 15 of the Kerala Co-operative Societies Rules, 1969;

AND WHEREAS, the Registrar of Co-operative Societies has forwarded to Government the resolution of the Board of Directors of the Kuthuparamba Co-operative Urban Bank Limited No.985 in Kannur District to exempt the said Bank from the provisions of clause (c) of sub-section (1) of section 7 of the Kerala Co-operative Societies Act, 1969 (21 of 1969) for enabling him to alter the classification of the said Bank as a Regional Co-operative Bank under rule 15 of the said Rules;

AND WHEREAS, the Government have examined the matter in detail and are satisfied that it is necessary, in public interest, to exempt the Kuthuparamba Cooperative Urban Bank Limited No.985 in Kannur District from the provisions clause (c) of sub-section (1) of section 7 of the Kerala Co-operative Societies Act, 1969 (21 of



1969), so as to enable the Registrar of Co-operative Societies to alter the classification of the said Bank as a Regional Co-operative Bank;

Now, Therefore, in exercise of the powers conferred by section 101 of the Kerala Co-operative Societies Act, 1969 (21 of 1969), the Government of Kerala hereby exempt the Kuthuparamba Co-operative Urban Bank Limited No.985 in Kannur District from the provisions of clause (c) of sub-section (1) of section 7 of the said Act for the purpose of enabling the Registrar of Co-operative Societies to alter the classification of the said Bank as a Regional Co-operative Bank, subject to amendment of bye-law for the change of name and classification of the said Bank.

Explanatory Note

(This does not form part of the order, but is intended to indicate its general purport.)

As per clause (c) of sub-section (1) of section 7 of the Kerala Co-operative Societies Act, 1969 (21 of 1969), the area of operation of a society and the area of operation of another society of similar type shall not overlap. The Kuthuparamba Cooperative Urban Bank Limited No.985 in Kannur District which is classified as a Primary Urban Co-operative Bank is having its area of operation in the Municipality of Kuthuparamba and Panchayath of Mangattidam, Kottayam and Pattiam of Tellicherry taluk in Kannur District. Six Primary Co-operative Banks which are classified as Primary Agricultural Credit Societies are also functioning in the same area of operation of the Kuthuparamba Co-operative Urban Bank. The Reserve Bank of India has rejected the request of Kuthuparamba Co-operative Urban Bank Limited No.985 in Kannur District under the Banking Regulation Act, 1949 (Central Act No.10 of 1949) to continue as an Urban Co-operative Bank. Hence, the Board of Directors of the Kuthuparamba Co-operative urban Bank Limited No.985 in Kannur District has resolved to request the Government through the Registrar of Co-operative Societies to exempt the said Bank from the provisions in clause (c) of sub-section (1) of section 7 of the said Act for the purpose of enabling the Registrar of Co-operative Societies to alter



the classification of the said Bank as a Regional Co-operative Bank. The Registrar of Co-operative Societies has forwarded to Government the resolution of the Kuthuparamba Co-operative Urban Bank Limited No.985 in Kannur District to exempt the said Bank from the provisions in clause (c) of sub-section (1) of section 7 of the said Act. Government have examined the matter in detail and are satisfied that it is necessary, in public interest, to exempt the Kuthuparamba Co-operative Urban Bank Limited No.985 in Kannur District from the provisions in clause (c) of sub-section (1) of section 7 of the Kerala Co-operative Societies Act, 1969 for the purpose of enabling the Registrar of Co-operative Societies to alter the classification of the said Bank as a Regional Co-operative Bank, after amending its bye-law for the change of name and classification.

This order is intended to achieve the above object.
