The following Draft Rules further to amend the Kerala Co-operative Societies Rules, 1969, which the Government of Kerala propose to make, in exercise of the powers conferred by section 109 of the Kerala Co-operative Societies Act, 1969, (Act



21 of 1969), is hereby published for general information as required under sub- section (1) of section 109 of the said Act;

Notice is hereby given that the said Draft Rules will be taken up for consideration on or after fifteen days from the date of publication of this notification and that suggestions or objections, if any, in respect of the said Draft Rules, which may be received from any person before the date specified above, will be considered by the Government. Suggestions or objections if any, on the Draft Rules shall be addressed to the Secretary to Government, Co-operation Department, Government Secretariat, Thiruvananthapuram.

DRAFT RULES

- 1. Short title and commencement.- (1) These rules may be called the Kerala Cooperative Societies (.....Amendment) Rules, 2023.
 - (2) They shall come into force at once.
 - 2. Amendment of the Rules .- In the Kerala Co-operative Societies Rules, 1969,-
 - (1) in rule 182,-
 - (i) in sub rule (4),-
 - (a) in clause (i),-
- (i) after the words "The society shall report the vacancy" the words "within a period of three months from the date in which the vacancy has been originated thereto" shall be inserted;
- (ii) after the words and symbol "from time to time." the following words shall be inserted, namely:-
- "If more than one Society included in the notification the candidates, along with the application, shall submit their priority list of societies for getting appointment included in the notification."
- (iii) after the words and symbol " The arrangements for the written test shall be made by the Examination Board." the following words shall be added, namely:-



"Once the vacancies reported by the societies to the Examination Board, the societies should not revoke such report without the prior permission of the Registrar."

- (b) in clause (iii) for the figure "80" the figure "100" shall be substituted;
- (c) in clause (iv) for the figure "15" the figure "20" shall be substituted;
- (d) in clause (vi) for the word "return" the word "prepare" shall be substituted:
- (e) in clause (vii) for the sentence "Examination Board will advise such list of candidates based on the vacancies reported by the respective societies," the following sentences shall be inserted, namely:-

"Candidates shall have the right to submit revised priority list of societies for getting appointment within 15 days of publication of such rank list to the Examination Board. Examination Board will advice such list of candidates based on the priority list submitted by the candidates and vacancies reported by the respective societies. If the candidates so advised included in the rank list of other societies mentioned in the notification, Examination Board shall not further advise such candidates for appointment to the vacancies of such societies."

(f) in clause for clause (viii), the following clause shall be substituted, namely:-

"(viii) All appointments to the vacancies shall be made by the committee from the rank list so published within one month from the date of such advise and shall be reported to the Examination Board. All vacancies arising during the existence of said rank list shall be reported to the Examination Board and such vacancies shall be filled up by the committee from the list of candidates so advised. Candidates shall join duty within 30 days of the receipt of appointment order of the society. Such joining time may be extended to a further period of 45 days with the prior permission of Registrar. If the candidates not joining the duty within the period, the committee shall report such vacancies as Non Joining Duty to the Examination Board within 15 days of the expiry of such joining time."

- (g) after clause (ix) the following clause shall be added, namely:-
- "(x) Society covered by Section 80 B of the Act shall send a copy of the concerned pages of Service Book of employees contained the name and address, photo, personal marks of identification, specimen signature and thump impression and



copies of certificates submitted by the employees duly attested to the Co-operative Service Examination Board within one month from the date of appointment. The Examination Board shall direct such employees to be present for certificate verification and verify the genuineness of attested copies and return it to the society with verification report within nine months from the date of receipt of attested copies from the society."

- (ii) for sub rule (6) the following shall be substituted, namely:-
- "(6) In all cases of selection, except those in the executive and supervisory cadres, differently abled candidates shall be given grace marks subject to a maximum 10 percent of disability. The total marks obtained in written examination and the grace marks for disability awarded to the candidate shall not exceed to the maximum marks of written examination."
- (2) In sub-rule (3) of rule 182 A, after clause (iii) the following proviso shall be inserted, namely:-
- "Provided that if there are more than five societies in a notification for the same post, applicant can only apply for five societies or 10% of such societies in the notification whichever is higher."
- (3) in sub-rule (9) of rule 182 B, in the following words shall be added at the end, namely:-
 - "Duties to be preferred by the members shall be decided by the Board."
- (4) in sub-rule (2) of rule 184, the following words shall be added at the end, namely: -
- " and based on the verification report of the Co-operative Service Examination Board as per clause (x) of sub-rule (4) of rule 182 and the appointment shall be made only after a Police Verification Report of the candidate concerned."
- (6) in rule 186,-
 - (i) in sub rule (1),-



(a) in entries (ii), the following entry shall be substituted, namely:-

"(ii) Other supervisory and Ministerial other than those requiring technical qualifications, the starting pay which is below Rs.250 as it existed on the 1st January 1974 and such pay being revised from time to time.

SSLC or its equivalent and successful completion of the Subordinate Personnel Co-operation Training Course (Junior Diploma in Co-operation)."

(b) for entry (iii), the following entry shall be substituted, namely:-

"(iii) Typist

SSLC or its equivalent with KGTE (English and Malayalam) Typewriting (Lower) or its equivalent "

(c) for entry (iv), the following entry shall be substituted, namely:-

"(iv) Stenographer

SSLC or its equivalent with typewriting and shorthand (Lower in English and Malayalam) or its equivalent."

(d) after entry (iv) the following entry shall be inserted, namely:-

"(ivA) System Administrator

First class B. Tech degree in Computer Science/ITI Electronics and communication Engineering /M.C.A./M.Sc (Computer Science or IT)

Desirable: Red Hat certification will be an added advantage

Experience: Minimum working a experience of three years in installing, configuring and trouble shooting UNIX/Linux base environment Solid Experience in the three application stacks(eg. Tomcat, JBoss, Apache, NGINX)

Experience with monitory system(eg.Nagois).

Experience scripting skills (eg.shell scripts, pearl,python).

Solid networking knowledge (OSI network layers, TCP/IP)

Experience with SAN storage environment with NFS mounts and physical and logical volume management.

Experience with tape Library backup.

(iv B) System Supervisor

(i) Any Bachelor Degree of a recognised University and (ii) Post Graduate Diploma in Computer Applications.



(iv C) Data Entry Operator

- (i) Any Bachelor Degree of a recognised University and
 (ii) A Certificate Course in Data Entry from an
 Institute Approved by Government
 of Kerala /Government of India.
 - (iii) Minimum one year experience in Data Entry Operator in a recognized firm".
- (e) after sub-rule (4) of rule 186, the following sub-rule shall be inserted, namely:-
- "(5) Notwithstanding anything contained in these rules or orders issued hereunder or in the bye-laws of any society or in the feeder category rules of any society relating to the qualification for appointments to the various posts and promotions of officers and servants for which direct recruitment is resorted to through the Co-operative Service Examination Board as per Section 80 B of the Act, the qualification and promotion prescribed for each posts shall be as per the conditions laid down in the recruitment rules of each class of societies which is approved by Government in consultation with Registrar of Co-operative Societies and Co-operative Service Examination Board."
