ORDER

G.O.(P)No.209/2023/Co-op Dated, Thiruvananthapuram, 17th October, 2023.
30th Kanni, 1199.

S. R. O. No. 1098/2023

WHEREAS, under sub-section(4) of section 69 of the Kerala Co-operative Societies Act 1969, (Act 21 of 1969), as amended by the Kerala Co-operative Societies (Amendment) Act 2013, (Act 8 of 2013), provides that all monetary



disputes mentioned in Schedule III to the Act shall be filed within the time limit specified in the said Schedule;

AND WHEREAS, the Government had exempted all Co-operative societies from the provision of sub-section (4) of section 69 of the Kerala Co-operative Societies Act 1969, (Act 21 of 1969) for a period of one year with effect from 14th February, 2013 to 13th February, 2014 in pursuance of notification issued under G.O.(P)No.136/2013/Co-op dated 13th October, 2013 and published as S.R.O. No.875/2013 in the Kerala Gazette Extraordinary No. 3138 dated 01st November, 2013, and extended for a further period of one year ten months and eighteen days from 14th February, 2014 to 31st December, 2015 in pursuance of notification issued under G.O.(P)No.35/2015/Co-op dated 27th February, 2015, and published as S.R.O. No. 112/2015 in the Kerala Gazette Extraordinary No.484 dated 06th March 2015, and extended for a further period of four years and three months from 01st January, 2016 to 31st March, 2020 in pursuance of notification issued under G.O.(P)No.121/2019/Co-op dated 18th November, 2019 and published as S.R.O No. 920/2019 in the Kerala Gazette Extraordinary No. 2887 dated 26th November, 2019 and extended for a further period of two years from 01st April, 2020 to 31st March, 2022 in pursuance of notification issued under G.O.(P)No. 37/2022/Co-op dated 1st April, 2022 and published as S.R.O No. 338/2022 in the Kerala Gazette Extraordinary No. 1142 dated 02nd April, 2022, and extended for a further period of three months from 01st April, 2022 to 30th June, 2022 in pursuance of notification issued under G.O.(P)No.99/2022/Co-op dated 8th June, 2022 and published as S.R.O No. 575/2022 in the Kerala Gazette Extraordinary No. 1912 dated 09th June, 2022 and extended for a further period of six months from 01st July, 2022 to 31st December, 2022 in pursuance of notification issued under G.O.(P)No.226/2022/Co-op dated 8th December, 2022 and published



as S.R.O No. 1188/2022 in the Kerala Gazette Extraordinary No. 4194 dated 08th December, 2022 and the extended period also expired on 31st December, 2022;

AND WHEREAS, the Registrar of Co-operative Societies has reported that the exemption granted was inadequate to comply with the statutory requirements and has recommended to extend the exemption for a further period of one year from 1st January, 2023 to 31st December, 2023;

AND WHEREAS, the Government have considered the matter in detail and are satisfied that it is necessary in public interest to extend the period of exemption granted to all Societies from the provisions of sub-section (4) of Section 69 of the Kerala Co-operative Societies Act, 1969 (Act 21 of 1969), for a further period of one year from 1st January, 2023 to 31st December, 2023;

NOW, THEREFORE, in exercise of the powers conferred by section 101 of the Kerala Co-operative Societies Act, 1969, the Government of Kerala hereby exempt all Co-operative Societies from the provisions of sub-section (4) of section 69 of the Kerala Co-operative Societies Act, 1969 (Act 21 of 1969), for a further period of one year from 1st January, 2023 to 31st December, 2023.

Explanatory Note

(This does not form part of the order, but is intended to indicate its general purport.)

As per sub-section (4) of section 69 of the Kerala Co-operative Societies Act, 1969, all monetary disputes mentioned in Schedule III to the Act shall be filed within the time limit specified in the said Schedule. The Government had exempted all co-operative societies from the provisions of sub-section (4) of section 69 of Kerala Co-operative Societies Act, 1969 (21 of 1969) for a period of one year with effect from 14th February, 2013 to 13th February, 2014 in pursuance of notification issued under G.O.(P)No. 136/2013/Co-op dated 13th October, 2013 and published as S.R.O No. 875/2013 in the Kerala Gazette Extraordinary No. 3138 dated 01st November, 2013, and extended for a further period of one year ten months and eighteen days from 14th February, 2014 to 31st December, 2015 in pursuance of notification issued under G.O.(P)No.35/2015/Co-op dated 27th February, 2015 and published as S.R.O No. 112/2015, in the Kerala Gazette Extraordinary No. 484 dated 06th March, 2015, and extended for a further period of four years and three months from 01st January, 2016 to 31st March, 2020 in pursuance of notification issued under G.O.(P)No.121/2019/Co-op dated 18th November, 2019 and published as S.R.O No. 920/2019 in the Kerala Gazette Extraordinary No. 2887 dated 26th November, 2019 and extended for a further period of two years from 01st April, 2020 to 31st March, 2022 in pursuance of notification issued under G.O.(P)No.37/2022/Co-op dated 01st April, 2022 and published as S.R.O No. 338/2022 in the Kerala Gazette Extraordinary No. 1142 dated 02nd April, 2022 and extended for a further period of three months from 01st April, 2022 to 30th June, 2022 in pursuance of notification issued under G.O. (P)No. 99/2022/Co-op dated 08th June, 2022 and published as S.R.O No.



575/2022 in the Kerala Gazette Extraordinary No. 1912 dated 09th June, 2022 and extended for a further period of six months from 01st July, 2022 to 31st December, 2022 in pursuance of notification issued under G.O.(P)No.226/2022/Co-op dated 8th December, 2022 and published as S.R.O No. 1188/2022 in the Kerala Gazette Extraordinary No. 4194 dated 08th December, 2022 and the extended period also expired on 31st December, 2022. The Registrar of Co-operative Societies has reported that the exemption granted was inadequate to comply with the statutory requirements and has recommended to extend the exemption for a further period of one year from 01st January, 2023 to 31st December, 2023. The Government have considered the matter in detail and are satisfied that it is necessary in public interest to extend the period of exemption granted to all societies from the provisions of sub-section (4) of Section 69 of the Kerala Co-operative Societies Act, 1969 (Act 21 of 1969), for a further period of one year from 01st January, 2023 to 31st December, 2023.

The order is intended to achieve the above object.
